19 JUNE 2018

SERIOUS YOUTH VIOLENCE

In response to growing concerns over young people's involvement in violent crime and a new focus on establishing a 'public health model' policy response, the group held a roundtable with the APPG on Knife Crime. Among the attendees was Sophie Linden, London's Deputy Mayor for Policing and Crime, as well as representatives from the Metropolitan Police and voluntary sector.

5 SEPTEMBER 2018

ATTRACTING THE SKILLS AND TALENT THAT LONDON'S BUSINESSES NEED

Speakers from the CBI, FSB, FutureLearn and the King's Commission on London discussed the opportunities and challenges the capital faces as businesses strive to meet their skills needs.

17 OCTOBER 2018

THE BUDGET, THE SPENDING REVIEW, AND THE FUTURE OF LONDON'S LOCAL SERVICES

Parliamentarians received an expert briefing on the upcoming Budget and 2019 Spending Review, including a presentation from the Institute for Fiscal Studies.

The APPG's co-chairs then wrote to the Chancellor of the Exchequer, making the case for "investment and support for London's local public services, infrastructure and businesses so that the capital continues to deliver growth not only for Londoners themselves, but for the country as a whole."

31 OCTOBER 2018

AUTUMN RECEPTION

Guest speaker Jo Johnson MP, who at the time was Minister for London and Minister of State for Transport, shared his reflections on the recent Budget and his priorities for the capital.



28 NOVEMBER 2018

SKILLS & APPRENTICESHIPS

In a joint meeting with the APPG for Greater Manchester, the group considered how further devolution could help improve the skills system and deliver high-quality apprenticeships.

Guest speakers included Cllr Georgia Gould, London Councils' Executive Member for Skills & Employment, Cllr Sean Fielding, representing the Greater Manchester Combined Authority, and Thaddaeus Brown, who shared his perspective as an apprentice at Hackney Council.

Following this event, the group's co-chairs wrote to and secured a meeting with Anne Milton MP, Minister of State for Skills & Apprenticeships.



11 FEBRUARY 2019

BREXIT AND LONDON'S BUSINESSES

With Brexit dominating the political agenda, the group organised a briefing from senior business figures from three key sectors in the capital. Mark Reynolds, the chief executive of construction firm Mace, Rachel Kent, partner at law firm Hogan Lovells, and Seth Williams, head of public affairs at the Association of British Insurers, discussed Brexit's implications for their business sectors.


London Councils provides the secretariat to the group on behalf of London government, including the Mayor of London and the London Assembly. The group is listed on the APPG Register.
